DECLARATION UNDER REGULATION 3

DETERMINATION UNDER SUBREGULATION 4(2)

- I, WILLIAM PATRICK DEANE, Governor-General of the Commonwealth of Australia, acting under the Australian Active Service Medal 1945-1975 Regulations set out in the Schedule to Letters Patent dated 11 December 1997 ("the Regulations"), and on the recommendation of the Minister for Defence Industry, Science and Personnel:
- (a) declare, under regulation 3 of the Regulations, Defence Force activities in the Federation of Malaya and the Colony of Singapore during the period that commenced on 16 June 1948 and ended on 31 July 1960 to be a prescribed operation for the purposes of the Regulations; and
- (b) **determine**, under subregulation 4(2) of the Regulations, that the conditions for award of the Australian Active Service Medal 1945-1975 with clasp 'MALAYA' in respect of that prescribed operation are:
 - (i) the Medal may be awarded to a person who, as a member of the Defence Force, qualified for the Naval General Service Medal with clasp 'MALAYA' in accordance with the conditions for that award set out in Command Paper 7907 dated March 1950;
 - (ii) the Medal may be awarded to a person who, as a member of the Defence Force, qualified for the General Service Medal with clasp 'MALAYA' in accordance with the conditions for that award set out in Command Paper 7907 dated March 1950; and

the Medal may be awarded to a person who, in accordance with a (iii) determination made by the Minister under paragraph 4(1)(b) of the Regulations, is in a class of persons who may be awarded the Medal with clasp 'MALAYA'.

Classes of persons who may be awarded the Australian Active Service Medal 1945-1975 with clasp 'MALAYA'

For the purposes of paragraph 4(1)(b) of the Regulations, I determine the persons described below to be a class of persons who may be awarded the Australian Active Service Medal 1945-1975 with clasp 'MALAYA':

- (a) Australian civilians who qualified for the Naval General Service Medal with clasp 'MALAYA' in accordance with the conditions for that award set out in Command Paper 7907 dated March 1950; and
- Australian civilians who qualified for the General Service Medal with (b) clasp 'MALAYA' in accordance with the conditions for that award set out in Command Paper 7907 dated March 1950.
