Together, Mr Cordon and the second friend dragged the distressed man into the boat where they were able to revive him.

When confronted, the man left the office and ran down the corridor, with the principal in pursuit. Mr Peter Orr, a teacher's aide, heard the principal's calls for assistance, left his classroom, and saw the offender running towards him in the corridor. In an attempt to apprehend the offender, Mr Orr grabbed him by the jacket, with the momentum throwing them both to the floor. At the same time, the offender saw Mr Orr moving to intercept him and produced a knife, which he used to stab Mr Orr in the head. As the principal reached the men he observed that Mr Orr had sustained an injury to the left side of his head, and he saw a knife on the floor between them. Mr Orr continued to struggle to restrain the offender until he was overcome by his injuries, and the offender was able to escape. Despite medical intervention, Mr Orr died a few days later as a result of the serious brain injuries he had sustained.
