Although he was almost hit in the head by the knife, Senior Constable Abernethy was able to restrain the remaining offender until fellow police officers arrived.

They made their way through the smoke and heat and found the man unconscious. Senior Constable Senff and his fellow officer then dragged the man to safety.

Mr Jason-Leigh STRIEGHER, Victoria Police

In the early afternoon of 23 February 1999, Mr Striegher attempted to apprehend an armed offender at Heidelberg, Victoria.

Around noon, Mr Striegher (who was a member of the Victoria Police at the time of the incident) responded to a call from a fellow police officer in pursuit of an offender, wanted for questioning in connection with shootings in the Melbourne area. The second police officer then left his vehicle and fired at the offender to protect Mr Striegher. A further exchange of fire occurred and, finally, the offender was restrained.
