On the afternoon of 21 November 2003, Mr Breen rescued a man from a burning vehicle after an accident at Mount Inkerman, Queensland.

Mr Breen was driving north along the Bruce Highway when he noticed an approaching car drift onto the other side of the road, narrowly missing his own vehicle. The car careered across a concrete culvert toward a raised train carriageway before landing upside down on the tracks. Mr Breen saw the accident in his rear vision mirror and called 000 emergency. He then heard the female driver, who had escaped, scream that her husband was trapped in the overturned vehicle. Mr Breen rushed to help. As he approached the car, he noticed smoke coming from the engine bay and that the grass surrounding the car was alight. Mr Breen tried all the doors of the car but they were jammed shut. To free the man he climbed through the front passenger window and dragged him from the burning vehicle. Another person who had arrived on the scene helped Mr Breen move the man to safety. Within 30 seconds the car exploded. In quick succession it then exploded a second time.

Mr Wust stopped his car and asked his wife to turn on the hazard warning lights and to ring 000 emergency. He then ran to the overturned vehicle and saw a man and woman trapped inside in their seats. Both were unconscious. The driver's door was jammed and the car had burst into flames. Mr Wust realised the man and woman would burn to death if he did not act quickly. After considerable effort, he forced open the back door on the driver's side, freed the female driver from her seat belt and dragged her out of the car. The flames were now spreading, with the engine compartment well alight. Mr Wust could feel the heat from the front of the car. Although someone yelled at him not to go back into the vehicle because it was about to explode, Mr Wust returned to help the trapped male passenger. He climbed over the heavy set man and managed to free his broken foot and drag him through the back door of the car. Other people helped Mr Wust to move the man and the woman away from the car before it exploded.

Realising he could not carry both of them, Mr Andrew asked the girl to tread water and float on her back while he supported her and at the same time held on to the younger boy. By now they were 500 metres out to sea. Mr Andrew continued to comfort and support the children until another board rider came to help. Mr Andrew and the other man put the children on the board and swam and pushed them back to the shore.

## Mr Rodney Warren BARBER, Mount Martha Vic 3934

On 13 May 2003, Mr Barber rescued a man from rough seas near Flinders, Victoria.

Mr Barber was a member of a coastal surveillance team that had intercepted an abalone poaching operation. An offender fled the scene and became trapped in remote and inaccessible terrain and required rescuing. Weather conditions meant that it would not be possible to execute either a beach landing or a helicopter winching operation to rescue the offender who was located sheltering in a cave at the base of a 50-metre cliff face. Mr Barber was in a patrol boat that was approximately 100 metres from the man but due to the three-metre swell and hidden rocks could get no closer. Mr Barber decided to swim from the boat to the cave, towing a life buoy attached to a rope. He rescued the offender, who was by then suffering from hypothermia and other injuries, towing him to the patrol vessel and helping him aboard so he could receive first aid treatment.

By his actions, Mr Barber displayed considerable bravery.

A police officer was trapped inside, unconscious, and her male colleague was trying to free her. By this time, two other bystanders had joined the rescue attempt. Mr Bennett helped pull the woman from the car and carried her about 10 metres from the burning vehicle. The car exploded soon after.

Following this, Nicholas disappeared under the dark and muddy water. Sadly, his body was retrieved by a neighbour later that day.

His father was covered in cuts and abrasions and told Mr Clarke he thought he had punctured a lung. As Mr Clarke was assisting his father to a safer spot they were hit by a wave and swept back into the ocean. Mr Clarke pulled himself onto the rocks, but saw his father had been caught in the churning current and was struggling to swim to safety. Mr Clarke asked his friends to phone emergency services, then swam back out approximately 70 metres to his father, grabbed hold of him and towed him to the rocks. Mr Clarke pushed his father into a more sheltered position on the rock edge away from the waves. Emergency services officers then abseiled down the cliff to assist Mr Clarke's father.

### Ms Kelly-Maree COYNE, Formerly New South Wales Police

When the male offender ran away Ms Coyle and her colleague pursued him. The offender started throwing heavy metal and wooden objects at Ms Coyle and the other officer. Some of the items hit Ms Coyne and injured her in the back. The offender then threatened Ms Coyne and her fellow officer with a long blade carving knife. When the offender turned on her colleague and tried to slash the other officer with the knife. Ms Coyne yelled at him to stop or she would be forced to draw her firearm. As a warning, she drew her gun, but then re-holstered it. The offender continued to run at the officers with the knife and a lump of wood. Ms Covne struck the offender a number of times with her baton, believing he was going to stab and seriously injure her colleague. After a time, Ms Coyne was able to handcuff the offender but was struck with a large piece of timber by another man. Eventually Ms Coyne and her colleague managed to get the offender into the police truck and take him to the station.

## First Class Constable David Malcolm ELSON, Western Australia Police

On the afternoon of 14 November 2001, First Class Constable Elson helped rescue several people in a plane crash near the Mount Monger Road, east of Kalgoorlie, Western Australia.

Constable Elson attended a crash scene involving a light plane that had attempted to make an emergency landing near Mount Monger Road. On arriving at the scene Constable Elson ran to the plane to check for casualties and found three men trapped inside, including the pilot who was deceased. Constable Elson cut the front passenger's seat belt but was unable to free him due to extensive damage to the plane requiring emergency equipment to assist. With fuel leaking over him, Constable Elson and others at the scene helped free the other injured passenger in the back seat while rescuers used a fire extinguisher to douse the fuel, which was forming a puddle under the plane. Constable Elson then helped hold up the right wing of the aircraft while fire officers used the jaws of life to cut open the aircraft and free the trapped front seat passenger. The injured man was then taken away by ambulance.

## Senior Constable Stephen Gregory FOX, New South Wales Police

When they arrived they were confronted by the offender who threatened to cut the face of the female officer with a pair of scissors. Senior Constable Gelme pushed the offender away from his colleague and pursued him. The male offender, agitated and abusive, threatened to harm the officers with a chair. At this point Senior Constable Gelme activated capsicum spray but strong winds interfered with the direction of the spray and some of the fumes came back on the officers. The offender threw several objects at the officers and eventually lunged at Senior Constable Gelme's colleague with a carving knife. Senior Constable Gelme pulled her away. The offender then turned on Senior Constable Gelme thrusting the knife towards his chest. Senior Constable Gelme ducked out of the way and attempted to hit the man with his baton. The offender continued to run at the officers with a knife and a lump of wood, striking Senior Constable Gelme in the upper chest just below his neck. Senior Constable Gelme staggered backwards but was still able to strike the offender with his baton, forcing the man to drop the wood and fall to the ground. As his colleague was handcuffing the offender, another man at the scene grabbed a police baton and hit Senior Constable Gelme on the right leg. Despite this, Senior Constable Gelme and his colleague continued to struggle with the offender until they managed to get him in the police truck and take him to the station.

Despite not being a strong swimmer, Mr Griffis towed the woman on his left arm across the current to land where others helped her to shore. Mr Griffis then returned to the man and pulled him to safety.

Mr Reader continued to stand his ground against the offender until police arrived and apprehended the man.

Constable Shanahan attended a crash scene involving a light plane that had attempted to make an emergency landing near Mount Monger Road. On arriving at the scene Constable Shanahan ran to the plane to check for casualties and found three men trapped inside. Constable Shanahan checked the pilot, but found no signs of life and helped pull the pilot's body from the wreck. Despite the danger from leaking aviation fuel, a decision was made to try to rescue the other two passengers. He then assisted in several unsuccessful attempts to free a seriously injured passenger in the front seat of the plane. Due to the extent of damage to the plane, emergency equipment was required. With fuel leaking over him, Constable Shanahan and the other officers helped free a second injured passenger in the back while rescuers used a fire extinguisher to douse the fuel, which was forming a puddle under the plane. Constable Shanahan then helped hold up the right wing of the aircraft while fire officers used the 'jaws of life' to cut open the aircraft. Constable Shanahan and ambulance officers then freed the remaining front seat passenger and carried him away from the aircraft.

## Sergeant Philip Martin SPENCE, Australian Federal Police

On 18 January 2003, as bushfires encroached on and destroyed parts of urban Canberra, Sergeant Spence, at the height of the firestorm, entered burning homes to evacuate residents and later in the face of significant threat acted to secure a magazine store located at the Weston Police Complex.

During the late morning of 18 January Sergeant Spence was called to duty as part of the emergency response to the fires. He initially commenced traffic control in a high-risk area and as conditions deteriorated over the day patrolled the immediate fire zone in the Chapman area on foot entering burning properties, alone and in the company of another rescuer, to ensure residents were safely evacuated. When he became aware that the firearms range at the Weston Police Complex was on fire he was concerned about the risk of fire destroying a magazine located at the Complex. Realising the seriousness of the situation, Sergeant Spence went to the Complex and entered the office area adjacent to the magazine. He saw that the office was filled with smoke, visibility was low and breathing difficult. Sergeant Spence entered the magazine with another police officer, checked the items stored inside and secured area. Sergeant Spence then went to the nearby firearms range at the Complex where small arms ammunition was exploding and assisted in fighting the fire at the range before being relieved. He then returned to the magazine store. Sergeant Spence remained on duty at the Complex throughout the night putting out spot fires.

By his actions, Sergeant Spence displayed considerable bravery, particularly in the Chapman area and at the Weston Police Complex.

The first three jumpers exited the aircraft successfully. As the tandem divers jumped, part of their harness snagged around the starboard wheel strut leaving them hanging mid air attached to the undercarriage of the Cessna. As soon as she became aware of the emergency, Ms Strathern executed some turns of the aircraft to try to free the jumpers. The manoeuvres did not work, so Ms Strathern leant out of the aircraft keeping one hand on the controls while trying to pull the harness strap free from the strut. When this failed, one of the trapped jumpers called out to her to cut them free. Ms Strathern immediately loosened her seatbelt, crouched on the floor of the aircraft and once again leant out and this time cut the harness with a knife. Ms Strathern had no parachute and, because the plane had no autopilot, she had to control it with one hand while cutting free the pair. She was flying at 7,000 feet at the time.

On the morning of 19 June 2000, Mr Taylor intervened in an armed robbery at the Westpac Bank in Bundall on the Gold Coast, Queensland.

Mr Taylor was at a Westpac branch when an armed offender, wearing a full-face balaclava and holding a .22 calibre rifle, ran up to a female teller, demanding money. Fearing for the woman's safety, Mr Taylor walked behind the armed man, grabbed hold of him from behind and twisted the man's left arm, forcing the gun to point away from the teller. The offender struck Mr Taylor on the head and body with the rifle several times while continually shouting threats at him. Mr Taylor wrestled the offender to the front door, but the armed man continued to hit and threaten him. Once outside the bank, the offender hit Mr Taylor with such force that the rifle smashed in two, slicing a deep gash across Mr Taylor's head, which later required 10 stitches. Mr Taylor threw a rubbish bin at the offender before withdrawing to seek help. The offender re-entered the bank and stole a large sum of money from the teller before escaping in a vehicle. Mr Taylor took down the vehicle's registration number and provided police with a description of the car. The offender was later apprehended.

On the afternoon of 18 January 2003 severe bushfires accelerated by extreme weather conditions encroached on urban areas of Canberra causing the tragic death of four people, the loss of almost 500 homes and 93 community, commercial and farm buildings, damage to many other homes and businesses as well as major disruption to the city's infrastructure and widespread destruction of forests and the environment.

A State of Emergency was declared in the early afternoon. Members of the group worked in the Weston Creek area at the height of the firestorm where it had the greatest impact, particularly in the suburbs of Chapman, Duffy, Rivett and Holder. They worked in a unit manner as individuals and in small teams under extremely dangerous conditions to protectives and property at great personal risk to themselves, evacuating residents and animals, directing anxious and distressed people to safety, and providing medical aid. Some members of the group entered burning buildings to ensure residents had evacuated to safety. All were exposed to huge walls of flames being fuelled by nearby pine forests and strong winds, exploding gas lines and cylinders, falling power poles and trees that were well alight. Intense smoke limited vision and made breathing difficult. Their efforts continued well into the night.

On the afternoon of 4 November 2001, a number of members of various emergency service organisations worked together to rescue a man pinned under rocks after a cliff collapse Bird Rock, Jan Juc, Victoria.

A group of surfers at Bird Rock were heading into the sea at high tide when they heard a rumble and turned to see the cliff face fall to the beach. A man tried to run, but was injured and fell over. He was pinned under rocks, with only his hand and forearm visible to onlookers. Police clambered over rocks and waded through the sea to help rescue the man and coordinate emergency service personnel. Smaller landslides kept occurring during the rescue effort, making the area extremely unstable, putting rescuers at risk. Personnel from the Country Fire Authority and State Emergency Service attended the scene and an ambulance crew monitored the rescue mission. The rocks were cleared as the tide started to recede and rescuers worked to free the man from the rocks. The man was eventually pulled free four hours later and taken to hospital. The rescue effort was perilous for all involved due to recurring landslides which destabilised the site.
