6 Period of operation

The declared operation occurred during the period beginning on 1 June 1999, and ending at the end of 19 May 2002.

- (1) The period within which each specified organisation participated in the declared operation is the period specified in Schedule 1 in relation to the organisation.
- (2) A period mentioned in Schedule 1 includes the days mentioned as the start and end of the period.
