Return of the writs for the 2025 federal election

I have the pleasure of returning the House of Representatives writs for each of the States and Territories, which were issued for the conduct of the 2025 federal election.

On behalf of the Australian Electoral Officers for the Australian Capital Territory and the Northern Territory, I am also returning the Senate writs for the Australian Capital Territory and the Northern Territory.

A certificate endorsed with the result of each election is attached to each writ.

The Senate writs for each of the States have already been returned to their respective State Governors. The State Governors were advised to return those Senate writs to you.

To determine accurately the commencement of the period from which petitions to the Court of Disputed Returns may be lodged under section 355 of the *Commonwealth Electoral Act 1918*, the High Court needs to be informed of the date on which the last returned writ for the 2025 federal election, held on 3 May 2025, is returned to you or in the case of the State Senate writ, to a State Governor.

I would appreciate written confirmation of this date so that I can pass that advice on to the High Court.
